I understand and accept that by signing below, I have requested for funds to be transferred out of my FXCM Asia account and into another FXCM account in accordance with FXCM Asia's compliance and administrative procedures. Moreover, I understand that FXCM Asia and FXCM LTD are regulated by different regulatory bodies. When I transfer my funds, those funds will be deposited in FXCM LTD's US bank Account. FXCM LTD is authorised and regulated by the Financial Services Authority, FSA Register Number: 217689, not by the SFC. Available margin must exist in order for funds to be transferred, as the removal of funds may result in a margin call. I shall hold FXCM Asia harmless of any and all claims regarding such a funds transfer upon proper credit to the above named FXCM LTD account. Forex and Over the Counter Gold Bullion/Silver (OTC Gold Bullion/Silver) do not trade on a centralized exchange system, open orders or positions may not be transferred. I authorize FXCM Asia to close any open positions with my agreement, and transfer the funds in the above amount to FXCM.
